

PLEASE READ CAREFULLY BEFORE SIGNING

INFORMED CONSENT, ACKNOWLEDGEMENT, WIVER, RELEASE AND INDEMNITY AGREEMENT

IN CONSIDERATION OF MY BEING PERMITTED BY CENTRAL ALBERTA FISH & GAME ASSOCIATION TO PARTICIPATE IN ANY WAY AT THE "POFIANGA" YOUTH CAMP, I, THE UNDERSIGNED USE, ACKNOWLEDGE AND AGREE THAT:

There are inherent risks, hazards and dangers to any person practicing primitive skills, survival training, camp and wilderness living techniques, particularly in a wilderness environment. I **UNDERSTAND THAT THESE RISKS, HAZARDS AND DANGERS INCLUDE, BUT ARE NOT LIMITED TO:**

- A. Exposure to variable extremes in weather that may cause injury due to cold or heat, and which may prevent or force itinerary changes.
- B. Remote locations with poor communication and the inability to get rescue or medical assistance easily or quickly.
- C. Encounters with wildlife, exposure to viruses, hiking and water hazards, injuries to self or from others, equipment hazards, and transport in any vehicle before or after an event to and from any location.

I FURTHER ACKNOWLEDGE AND AGREE THAT:

- 1. I am voluntarily participating and agree to accept all the risks and the possibility of death, personal injury, property damage and/or loss resulting from my involvement with the program, event and/or trip I am undertaking with "CENTRAL ALBERTA FISH & GAME ASSOCIATION-ZONE THREE"
- 2. I hereby KNOWINGLY AND INTENTIONALLY WAIVE, RELEASE, INDEMNIFY AND HOLD HARMLESS "CENTRAL AFGA ZONE 3, its Directors, Officers, employees, guides, agents, representatives, servants, successors from and against all claims, actions, causes of action, liabilities, suits, costs, expenses (including legal fees on a solicitor and his client bases) and

- demands of any nature or kind whatsoever, which are related to, or arise out of, or are in any way connected with my participating in the activities, including but not limited to NEGLIGENCE of any kind or nature whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, disability, paralysis, or death to me or my property as a result of my engaging in the activities or use of the services or equipment of CENTRAL AFGA ZONE 3. I, for myself, my heirs, successors, executors and family, further agree not to sue CENTRAL AFGA ZONE 3 as a result of any injury, disability, paralysis, or death with my participation in these activities, programs or other related events.
 - 3. I certify that I am physically capable and fit to participate in the activities and assume the responsibility for my physical fitness and the capacity to undertake such activities.
 - 4. I further acknowledge and agree that first aid and medical treatment may be given to me by the leader or instructor or medical personnel in attendance in the event of accident, injury or illness during my participation in these activities, programs or other related events and activities.
 - 5. I understand and agree that the acknowledgements, waivers, releases and indemnities outlined in this agreement are applicable as a condition to my participating in any activities of the CENTRAL AFGA ZONE 3.
 - 6. I am not relying on any oral or written representations or statements made by CENTRAL AFGA ZONE 3 or its agents, including those in any brochure, advertisements, or individual conversation to induce me to participate in the survival training camp or other activities, programs and events.
 - 7. Should CENTRAL AFGA ZONE 3, or anyone acting on their behalf, be required to incur lawyer's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
 - 8. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain if full force and effect.
 - 9. I confirm that I have read over this agreement before signing, that I understand it and that it will be binding on myself, my estate, my heirs, my next of kin, my executors, administrators, and assigns.

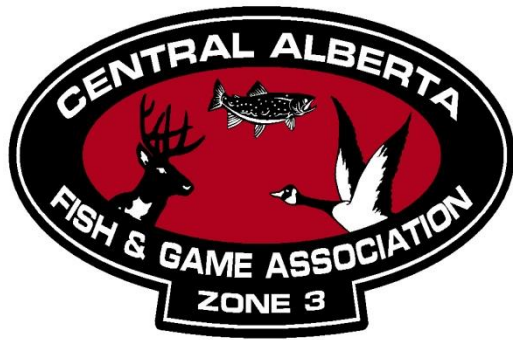

Dear Young Outdoor Enthusiasts:
Due to the overwhelming success of other camps, we will be holding a camp this summer for youths between the ages of 12 to 17. The YOUTH Camp will be a 6 day event of fun and learning.
EXPERTS will be sharing their knowledge and providing instructions in conservation, hunter training certification, survival, firearms safety, water safety, and many other activities.

The camp will be held at the Ponoka Fish & Game Club House (Pofianga). It is located: Take Exit 462 (Menaik) on Highway 2 west less than 1 mile (sign indicating Ponoka Fish & Game Association), turn left (south) at the first crossroad and drive south about 1 mile and you will see the gate on the east side, or to your left. **Participants MUST arrive between 12:00 noon and 4:00pm on Sunday afternoon.** The camp will start at 4:00pm with an orientation all participants must attend. Parents may stay until 5:00pm on Sunday. Participants are off limits in the camp kitchen and dining room. **Parents must pick up their children at 2:00 pm on Saturday, August 24, 2013 .There will be a wiener roast for everyone to enjoy.**

The cost is \$300.00, GST included. This fee includes lodging, Sunday evening supper, breakfast, lunch, and supper through Friday, and Saturday breakfast and lunch.

Upon successful completion of the courses taught, students will then be certified in the ALBERTA CONSERVATION AND HUNTER EDUCATION PROGRAM and THE CANADIAN FIREARMS SAFETY COURSE. They will then qualify for their WILDLIFE IDENTIFICATION NUMBER and their MINOR'S POSSESSION LICENSE.

Participants will be sleeping in cabins and adult supervision is always present.

What to bring
Numerous sessions are outside and hands-on. Hiking boots and running shoes are appropriate. Clothing for the camp should include long pants, rainwear, waterproof footwear, hat and any other seasonal items of clothing you may want to include. Other items are sunscreen insect repellent, sunglasses, camera, film, flashlight, alarm clock, a re-usable water bottle and reading material. Linens for the cabins are not supplied. Please bring your own foam mattress, pillow and sleeping bag. Make sure you bring your personal toiletries as well as towels and facecloths

NO AEROSOL CANS OF ANY KIND WILL BE PERMITTED.

Do not bring phones or electronic game of any kind!

THIS CAMP IS A DRUG AND ALCOHOL FREE AREA.

Anyone consuming and/or under the influence of alcohol or drugs or breaking camp rules will be required to leave these facilities immediately.
